The Government of Nepal has allocated funds towards the cost of **Construction of Bateshwor Rural Municipality Office Building** and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Bateshwor Rural Municipality Office Building (Contract No: 01/Works/NCB/BRM/075/076). Bidding is open to all eligible bidders.
2. Bateshwor Rural Municipality invites electronic bids from eligible bidders for the construction of Construction of Office Building, under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Bateshwor Rural Municipality, Bateswhor, Dhanusha, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
4. A complete set of Bidding Documents may be purchased from the office Bateshwor Rural Municipality, Bateswhor, Dhanusha, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 5000.0 NRs. till 26-03-2019 17:00 during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below

5. Sealed or electronic bids must be submitted to the office Bateshwor Rural Municipality, Bateswhor, Dhanusha, Nepal by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 27-03-2019 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 27-03-2019 14:00 hours at the office of Bateshwor Rural Municipality Bateswhor Dhanusha Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 9,60,00 which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Minimum Average Annual Construction Turnover of the best 3 years within the last 5 years must be 4,80,00,000.00 and Minimum Work experience of similar size and nature of three projects with contract value more then 2,60,00,000.00 excluding VAT.
